Call to Order:

Proof of Quorum:

Mike Romalin and Joe Harris were in attendance. A Quorum of the board was established.

Reading of the previous meeting minutes:

A **motion** was made by Mike Romalin to amend the February minutes to read that Mike Romalin was made President and the attorney will be mailing out default letters. Joe Harris made a motion to approve the amended minutes and Mike Romalin seconded and unanimously passed.

Treasurer's Report:

Joe Harris nominated Mike Romalin as Vice President, Tony Petricca seconded, John Harris nominated Tommy Aquila as Secretary, Tony Petricca seconded, John Harris nominated Joe Passanise as Treasurer, Tony Petricca seconded, unanimously passed. It was discussed that since Patricia Kunkle would not be attending any meetings until September, so she was not elected to the board.

Joe Passanise met with Extreme Fence regarding back gate. He is obtaining proposals.

Mike Romalin discussed shorting the entrance gates closing times between cars. A motion was made by Mike Romalin to shorten to 7 seconds. Joe Harris seconded by to re-look at in 30-days and unanimously passed.

Joe Harris made a motion to appoint Mark Grande to the roads committee, Tommy Aquila seconded.

Joe Harris made a motion to purchase RV cameras per quote plus 1 more camera and trim tree at RV lot gate. Joe Passanise seconded, unanimously approved.

Joe Harris discussed the quote from Red Hawk regarding license plate cameras in bollards. Doreen to get with Red Hawk to see just how many LP cameras are necessary to see all lanes.

Joe Passanise will meet with Clyde regarding what is wrong with the clubhouse doors.

The quote from Red Hawk for the DVD case was unanimously approved as well as replacing the locks on the guard house.

Tony to meet with Doreen regarding replacing the ballroom tabletops and have ready for next meeting.

Gate operators were discussed. Joe Harris polled the Board in regard to locking down the back, exit gate, all approved except Mike Romalin. It was discussed to look into installing a keypad for the back gate to open just like the entrance so someone can key in their code without using a remote. If approved, they can be installed with coinciding with road paving. It was decided that if the gate operators fail and you cannot get out the front gate automatically, the back, exit gate will be re-opened until keypad is installed.

Board unanimously approved renewing AquaSystem and D&O Insurance.
