Yoga Room HVAC:

Tommy Aquila motioned to approve Bay Area to install A/C in Yoga room, seconded by Joe Passanise, Tony Petricca was a no, Mike Romalin was a yes, Joe Harris was a yes and the motion passes. The board asked what the cost of a Thermostat would be verses using a remote.

Key Vista Master Treasurer's Report at the Association Meeting on June 25, 2019

Review and analysis of the financial documentation provided in the May 2019 Monthly Key Vista Master Board of Directors Report prepared by Leland Management has resulted in my following comments:

- Based upon the Budget Comparison for the month of May (5/1/19 to 5/31/19), the Actual Total Income was \$85,961.96, the Actual Total Expenses was \$54,020.60, and the Actual Net Income was \$31,961.36. This resulted in an accumulation of Net Income of \$145,978.73 since January 1, 2019 as described in the Balance Sheet, dated 5/31/2019.
- The Balance Sheet of 5/31/2019 also describes Total Association Assets of \$2,594,209.22. This includes Total Operating Cash of \$356,905,89 and Total Reserve Cash of \$2,181,100.17.
- The Aged Receivables (AR) Report lists 275 residents who have not paid their monthly Master fees. The total outstanding debt due to this lack of payments is \$52,961,20.
- There were 15 Master Common Area maintenance problems corrected in the Master Clubhouse and the Single Family Subdivision. This included landscaping, swimming pool/spa, streets/sidewalk repair, and general repair problems. There were no maintenance problems corrected on Master Common Areas in the Villas Subdivision.
